Discussion was held as to whether the Grand Valley Program Coach, should be a member of our Club and if their fees will cover this membership.

The Board recommended that the officers presently serving as Vice President, Recording Secretary and Executive Officer for Rifle and Air Gun, each be nominated for another three year term.

## GRRP CLUB BOARD MEETING 4/6/2016

Meeting was called to order at 7:18 pm. Board Members not in attendance were Phillips and Mertes. This will be the last regularly scheduled Board meeting for the 2015/2016 season. Notice of Annual Meeting will be sent out when a date is set.

Minutes of the March 9 th. meeting were read and approved.

Our 2700 Match that was to be held in March, was cancelled and Open Shooting held in its place.

Our Juniors continue to roll along in fine fashion. Ron Carr informed the Board that the NRA, in the form of a Grant, has given the Junior Program \$2637.00 worth of equipment.

The Air Gun Program will end Monday, April 11th., with a Fun Shoot. We will begin a new season in early October, 2016.

The Club has received from Modern Roofing Co., a bid to replace our present roof. This bid was \$23,000.00.

In the meantime, the club has received \$938.00 from our Insurance Company, for roof repairs. It will be determined at a later date, how these repairs will be made, and how much life it will provide to our existing roof.

The Club has also received \$4019.00 to repair the Air Makeup Unit, which was damaged during the attempted break-in.

It was brought up that Lead Removal must be addressed sooner rather than later for safety reasons. Dan McAdams will Email Ryan Phillips about the lead removal, and getting Ryan the proper help to accomplish this task.

Discussion was held on how to engage old and new members in Club activities and work projects. This is an ongoing and never ending subject for all members of the Board.

The Women on Target program held on April 4 th., was very well attended and went extremely well. Ron Carr will be looking into the possibility of holding another class the first or second week of May.

Expanded Open Shooting hours/days, may be possible in the 2016 - 2017, if enough Range Officers come forward to be trained and make a commitment to staff additional times.

It was determined that spent brass, that may be reloaded, is the property of the shooter. The shooter may pick up his brass or allow anyone of his choice to pick up this brass.

## GRRP BOARD MEETING - MARCH 9, 2016

Meeting called to order at 7:20 pm. Members not in attendance were Phillips, DaBakey and Dunn. Minutes of the February 10 meeting were read and approved. Next Board Meeting will be on April 6, 2016.

Postal entries have been turned in.

The 2700 Match in January had eight shooters. The second 2700 Match had a full line of twelve shooters.

It was reported that the Junior Program is going well. We are presently at five Air Gun Shooters and twelve BB Gun Shooters. Our kids are still looking to partner up with the Muskegon Juniors for a Clinic.

Air Guns, as always, are rolling along with steady attendance.

The Board, including the Building and Grounds Director, discussed the condition of the roof with action being taken in the near future, after a roofing contractor does an inspection. We also discussed limiting the amount of travel of the carriers, that will be allowed during CCW Classes. We may also purchase extra tables to place down range, in order to limit the travel of the carriers. It was brought up that it is difficult to tell when our cleaning service has done it's maintenance. The Range appears to have not been hosed down and we question if the Club Room has been wet mopped.

The Web page has been looking very good and we were informed that it will be looking even better.

Action Shooting will continue until the end of April.

The Women on Target program will be held on Saturday April 2nd. Some discussion was held on perhaps holding a small class in May.

It was moved and supported that the Club, if needed, would make up for any short fall in donations for Award Medals for our Veterans.

Dan McAdams presented the Board with printed copies of our cash flow, through the 29th of February, 2016.

Down Range lead removal is still being discussed and hopefully will be completed shortly.

The damage to our Air Makeup system has been estimated at \$4200., with the club having a \$500. deductible.

We will look at training some new Range Officers, that could be used for expanding Open Shooting hours next season.
